#### The program has stood the test of time

The 2013-2014 year was one of growth here at Forum. The Forum program has always been more than the week at Forum and this year we added more activities to the 3 months before Forum and the 6 months after in which youth can choose to share their voice.

Before arriving in Ottawa youth are asked to find out how decisions are made in their communities, and provinces. They are also asked to network with their peers in order to represent the priorities of youth in their area at the "Youth Priorities" conference during the week at Forum. This also prepares students for the MP Dinner and the chance to discuss with their MPs not only their priorities and the priorities of youth from their area but also the priorities of youth from across Canada.

Following Forum, participants are supported in sharing what they have learned with their peers, schools and communities. Additionally, participants have the opportunity to continue their learning experience through activities such as the recent teleconferences that were held with a speaker on aboriginal issues and a former Usher of the black Rod. Youth who participate in post-forum learning opportunities receive certificates of participation for their portfolios. For the coming year we will be bringing more opportunities for youth to participate in pre- and post-Forum activities with identified learning objectives and outcomes, highlighting core competency development.



## As we get ready to celebrate 40 years, we reflect on where it all began

#### Mission

**The Foundation** goal is to foster and promote an understanding among young Canadians of the role and function of Canada's three levels of democratic government, while promoting awareness of the meaning of Canadian citizenship.

#### History

1975 — Some idealistic educators had a great idea: to create a bilingual, non-partisan youth education program to promote understanding of the role and function of our national government and the meaning of Canadian citizenship. The idea would be to have today's young leaders interact with the nation's leaders on Parliament Hill. The Foundation for the Study of the Processes of Government was incorporated and its first program, the Forum for Young Canadians, was launched.

1976 — The first Forum for Young Canadians ("Forum") was run in March at Ashbury College, with 100 high school students (aged 15-19 years) from all over the country in attendance. Three more weeklong sessions would take place that year.

1985 — The Foundation created the Forum Teachers' Conference which offered teachers the same week of intense activity on Parliament Hill and other national facilities as the Forum students, making it one of the best professional development conferences in the country on learning the processes of government.

2000 — The Foundation created its first international program for students and teachers from eleven countries around the world who had attended, along with the Canadian team, the "World Parliament of Children" in Paris in 1999. Together, they attended Forum and presented the World Parliament of Children's "Youth Manifesto of the 21st Century" to the Parliament of Canada

2001 — The Foundation created the Canada-U.S. Youth Forum in partnership with the University of Ottawa. This program, for which participants can receive academic credit, was developed along the lines of Forum's educational "hands-on" approach.

but with more emphasis on issues relevant to the bilateral relationship between Canada and the United States. The program brings together primarily university-aged students from both countries for a one-week forum.

2003 — The Foundation partnered with the Institute for Cultural Diplomacy in Berlin to launch the Canadian-German Young Leaders Forum. This program, which the Foundation ran jointly with the ICD until 2006, gave young business, government and academic leaders from both countries (aged 28-38) a practical understanding not only of the processes of government at an international level but also of the international community in which governments operate.

Today — The Foundation began with the simple formula of bringing together interested and engaged youth from across the country to participate in a constructive and educational exploration of their national institutions. Our experience has shown that it was a formula for success.

The participants in the programs of the Foundation, who now number more than 16,000, reap a tremendous reward. They benefit greatly from the educational aspect of the programs, which is the original objective of the Foundation. They become better informed, more involved citizens, which in turn serves the public good across Canada.

Participants also have the important experience of meeting their peers from other parts of Canada. For many, their attendance at a Foundation program is their first such experience and it brings with it an important awareness of themselves and each other. What's more, they become a part of a broader network that extends across Canada.

# FOUNDATION FOR THE STUDY OF PROCESSES OF GOVERNMENT IN CANADA

Notes to Summary Financial Statements

Year ended July 31, 2014

Foundation for the Study of Processes of Government in Canada (the "Foundation") is a Canadian registered charity founded in 1975 and incorporated without share capital under Part II of the Canada Corporations Act. Its principal activity is the Forum for Young Canadians program whose objective is to give young Canadians the opportunity to gain a clear understanding of the processes of government in Canada with particular emphasis on the machinery of government in the federal capital.

#### 1. Summary financial statements:

The summary financial statements are derived from the complete audited financial statements, prepared in accordance with Canadian accounting standards for not-for-profit organizations, as at July 31, 2014 and for the year then ended.

The preparation of these summary financial statements requires management to determine the information that needs to be reflected in the summary financial statements so that they are consistent, in all material respects, with or represent a fair summary of the audited financial statements.

These summarized financial statements have been prepared by management using the following criteria:

- (a) whether information in the summarized financial statements is in agreement with the related information in the complete audited financial statements; and
- (b) whether, in all material respects, the summarized financial statements contain the information necessary to avoid distorting or obscuring matters disclosed in the related complete audited financial statements, including the notes thereto.

Management determined that the statement of changes in net assets and the statement of cash flows do not provide additional useful information and as such has not included them as part of the summary financial statements.

The complete audited financial statements of Foundation for the Study of Processes of Government in Canada are available upon request by contacting the Foundation.

#### 2. Economic dependence:

The Foundation receives a substantial portion of its operating funds from the Government of Canada and is economically dependent on its continuing support of the Foundation's mission.
